Do you use remarketing services for marketing & advertising purposes?

Say Yes if you do (or might do) remarketing ads (yes +34)

Do you want your Privacy Policy to include CCPA (California Consumer Privacy Act) wording?

Yes or No, depends on whether your business meets the following criteria:

CCPA essentially applies to any for-profit entity doing business in California that collects, shares, or sells California consumers' personal data, **AND**:

- Has annual gross revenues in excess of \$25 million; OR
- Possesses the personal information of 50,000 or more consumers, households, or devices; <u>OR</u>
- Earns more than half of its annual revenue from selling consumers' personal information.

(If this applies to you, select Yes +\$34)

NEW - if not added to TermsFeed yet, probably will be soon:

CPRA (california Privacy Rights Act) - expanding on CCPA

Applies to businesses defined as follows:

The CPRA defines a "business" as:

- a for-profit legal entity:
 - that collects consumers' personal information on its own or by others on its behalf
 - that alone or jointly with others determines the purposes and means of the processing
 - o that "does business" in California
 - o and satisfies at least one of the following thresholds:
- i. has annual gross revenues in excess of \$25 million
- ii. annually buys, receives, sells, or shares the personal information of 50,000 or more consumers, households, or devices
- lii. derives 50% or more of its annual revenues from selling consumers' personal information

If this applies to you, select Yes. If not, select No

Do you want your Privacy Policy to include GDPR wording?

Yes or No, depending on whether you do business in the EU (If you do business in the EU, then yes)

If yes, do you have a Facebook fan page? (yes +\$14)

Do you want your Privacy Policy to include CalOPPA wording?

Yes, if you do business in CA

CalOPPA applies to any person or company in the United States (and conceivably the world) whose website collects personally identifiable information from California consumers.
